The parties acknowledge that any amendments or modifications whatsoever to this Agreement shall be in writing. This Agreement shall be governed by the laws of the province of Saskatchewan."

Except as modified herein, all terms and conditions of the Landlord Service Transfer Agreement shall remain in full force and effect. All capitalized terms used but not defined shall have the meaning specified in the Landlord Service Transfer Agreement. References to the Agreement will be to the Agreement, as amended herein.
